### **Application for accreditation as an assessing body for the "Certified Passive House Tradesperson" qualification through trades documentation**

The Passive House Standard is the world's leading standard for energy efficient building construction. Competent qualified tradesperson are needed for the successful implementation of this building standard.

Certification as a "Certified Passive House Tradesperson" was developed by the Passive House Institute (hereafter referred to as PHI) to substantiate such qualifications.



Besides prolongation under participation in further training courses, the certificate for Certified Passive House Tradespersons can also be renewed by means of trades documentation.

For interested and qualified persons, the PHI offers the opportunity to be accredited as an assessing body which judge first these trades documentation.

This documentation serves as a means for the exchange of knowledge and expertise especially in relation to the construction of Passive House buildings or EnerPHit retrofits by providing a meaningful description of the executed work, with reference to specific challenges and interesting approaches that have been implemented.

The accredited assessing body shall forward the trades documentation to the PHI together with all other necessary documents after successful initial checking. After successful second checking, the PHI shall issue the "Certified Passive House Tradesperson" certificate.

The PHI shall charge the assessing body a fee for each set of trades documentation received by the PHI, the amount of which is set out in the fee schedule.

Trades documentation may be compiled in the languages offered by the assessing body; a summary must be provided in English.

The quality of the review of trades documents depends on the professional competence of the assessing body. A prerequisite for accreditation as an assessing body is that the assessors involved possess a sufficiently high degree of professional competence with regard to the execution of Passive House buildings.

For accreditation as an assessing body please fill in the form in Annexe 1 (Details of Assessing Body), and the form in Annexe 2 (Details of Assessor) for each assessor, and send both signed forms to us for checking (via post or e-mail).
