Application for accreditation as a course provider for the education programmes of the Passive House Institute

The PHI's education programmes aim to significantly improve the qualifications of building professionals and ensure the high quality required for the planning and construction of highly energy efficient buildings. The PHI has developed the "Certified Passive House Designer/Consultant", "Certified Passive House Tradesperson" certificates and various additional seals as proof of qualification. The criteria for this qualification are the same worldwide, so the qualification of construction professionals is internationally comparable and is of a consistently high standard.



These certificates may be obtained by passing an exam. The Passive House Institute offers interested persons the opportunity to be accredited as course providers. In addition to this, it is possible to obtain the right to use course material provided by the PHI in exam preparatory courses in order to impart sufficient knowledge required for a high quality of planning and construction of Passive Houses and refurbishments with Passive House components.

Basis for the certification through exams are the regulations for continuing education and the catalogue of learning targets provided by the PHI. Information regarding fees for offering the examinations as well as a one-time fee for the right to use the course material can be found in the respective fee schedules. The regulations for continuing education, learning targets and fee schedules are available at <u>www.passivehouse.com/training</u>.

In order to achieve a high standard of training, it is necessary that course providers maintain a high-quality standard, which significantly depends on the technical know-how and teaching skills of the instructors. Thus, specialist knowledge and project experience regarding Passive House as well as experience with continuing education is a prerequisite for the accreditation as an course provider and acquisition of the right of material use.

To prepare instructors for the continuing education the Passive House Institute offers a "Train-the-Trainer-Course". In this course, contents and organisation as well as didactic concepts of the course materials are presented. Technical knowledge and project experience regarding Passive House is assumed.

If you would like to be accredited as an course provider and would like to acquire the right of use of the course material, please fill in and sign Attachment 1 ("information about course provider") and a copy of Attachment 2 ("information about instructors") for each instructor and submit these to the PHI for assessment (by email). If the application is accepted, the PHI will send the corresponding contracts to the applicant.

The data of the applicant and the instructors obtained for this accreditation shall be stored and used by the PHI for the purpose of implementing the contractual agreement.
